## 12. Climate change

### 12.5 Climate change and environmental justice



Environmental justice is centred on the basic human right to a clean and healthy environment. Locally, nationally and globally the most vulnerable people with the least power and money often see this right denied. Whether it is to do with exposure to air pollution or flooding, the location of hazardous installations or simply not having access to the environment, the poorest in society are often disproportionately affected.

People living in the poorest neighbourhoods in the UK tend to be worst hit when the environment is damaged.

Deprived communities are, on average, less likely to have access to green spaces and to services, such as doorstep recycling, and are less likely to be prepared for extreme weather events such as floods.

The main cornerstones of environmental justice:

- Everyone has the right to a healthy and safe environment and the responsibility to maintain it.
- Everyone has the right to a fair share of natural resources and the right not to suffer disproportionately from environmental policies, regulations or laws.
- Everyone has a civil right to be able to access environmental information and participate in decision-making.
- The most vulnerable in society, in particular the poorest, should not suffer the disproportionate, negative effects of environmental omissions, actions, policy or law.

## Capacity Global

Capacity Global works specifically with people and communities in urban areas, who suffer most from environmental injustice, to ensure their voices get heard. They work with people on local environmental issues and work that tackles global challenges like climate change. They collaborate with diverse partners and networks and we work directly with the people that suffer the most from living in poor neighbourhoods. Because of this, Capacity Global is able to develop research, share knowledge and help provide solutions that challenge inequalities and provide resources that create healthy urban environments.
