7. Finding and getting money

7.4.14 Funding for places of worship

Introduction

There are a number of trusts and foundations which provide grant funding assistance specifically for places of worship such as religious buildings. The main potential funders are:

Welsh Church Act Fund

Promotes and supports the charitable activities of organisations which benefit local people and which enrich local communities, including any places of worship and burial grounds - restoration and maintenance. No maximum or minimum grant levels stipulated.

Where they are available, grants are administered by the local authority. Contact your local county voluntary Council for more information.

James Pantyfedwen Foundation

Minimum of £200 upwards at Panel's discretion, aimed at churches and charitable organisations. Grants are for capital expenditure – there is no revenue funding whatsoever.

Historic Churches Preservation Trust

This trust funds repairs to the fabric of churches (all Christian denominations over 100 years old), or enlargement of worship area or construction of new churches (Anglican only).

To help those applying for grants, the trust has developed two straightforward application routes:

- **General** covers structural repair work for which we award Cornerstone, Standard and Foundation grants.
- **Facilities** deals with facilities and access improvements which are covered by our Facilities grants.

It is important to make sure your project will be eligible by checking it meets the following criteria:

- All church building must be over 100 years old to qualify for a grant from the Trust. However, Anglican churches of any age which belong to the Church of England or the Church of Wales can apply to the Incorporated Church Building Society which works alongside the HCPT for grants.
- All churches must be open for regular public worship, be in England or Wales and belong to a denomination that is itself a member of Churches Together in Britain and Ireland.
- All projects must be overseen by an architect who is either ARB, RIBA or AABC accredited, or by a chartered surveyor who is RICS accredited.
- The work must cost more than £4,000 before VAT and fees.

Please be aware that the Trust cannot make grants for certain purposes including:

- Non-church buildings (such as church halls and vicarages)
- Bell, clock and organ repairs
- Repairs to internal furnishings

- Redecoration, other than after structural repairs
- Monument repairs
- Wall painting restoration
