7. Finding and getting money

7.4.13 Local funding - Neath Port Talbot

This information sheet is designed to give details about small grants, which are available for small groups and organisations within the voluntary sector in **Neath and Port Talbot**. The information is intended as a general guide, the contacts given will be able to provide you with more details about each grant. This sheet should be read in conjunction with **7.4.1 Small Grants** which details small grants which are available on a regional or all Wales basis.

Neath Port Talbot Capital Grants Scheme 2011/2012

Aim: A local grant fund that will target groups which provide or intend to provide services which impact on locally developed strategies.

Who can apply?

Voluntary organisations, charities and social enterprises that:

- Represent, serve or support people living in Neath Port Talbot.
- Are based in the County Borough of Neath Port Talbot (or provide a service of benefit to residents in Neath Port Talbot).
- Have an acceptable Governing Document, e.g. constitution, Memorandum and Articles of Association etc.

(Religious organisations **may** be eligible if they provide a community service that is open to all regardless of faith and can show that their project will not promote religious beliefs).

Priority will be given to groups that:

- Have not previously received CFAP funding.
- Have an annual income of less than £50,000.
- Work cooperatively with other organisations in the locality.
- Evidence working towards sustainable outcomes.
- Undertake activities that are open to all within the community.

What can it fund?

Capital projects which help provide facilities and equipment that help with the carrying out of activities that promote the regeneration of communities.

How much?

Grants from £500 to £10,000.

Deadline: There are four deadlines for 2011/2012. These are 30th June 2011, 22nd August 2011, 14th November 2011 and 14th February 2012.

Under 8's Small Grants Scheme

Aim: Grants are provided to help develop and support unregistered groups that provide facilities for children under 8 years old.

Who can apply?

Groups that are not registered with the Care and Social Services Inspectorate Wales (CSSIW) that work with children aged under 8. Groups may only apply once in a financial year, but may reapply the following year.

What can it fund?

Play equipment and materials to enhance all areas of child development, toys, safety equipment, storage and furniture, rent for a maximum of 26 sessions, promotional materials and advertising, membership fees to umbrella organisations and insurance.

How much?

Grants of up to £600 are available for groups that have been operating for less than 12 months, and up to £400 for those older than 12 months.

Deadline: The panel meets every six weeks.

Youth Opportunities Bank

Aim: Neath Port Talbot Youth Opportunities Bank is run by young people to support groups or individuals in the area with an activity benefiting young people and the community and providing new skills or experiences.

Who can apply?

Applicants must be aged between 16- 25 and be a group or individual living in Neath Port Talbot.

What can it fund?

Equipment to run activities such as a pool table, musical instruments or furniture etc, Trips, Events, Training, Workshops.

How much?

Grants range between £50-£500 (applications for more will be assessed on an individual basis).

Deadline: There are two deadlines for 2011/ 2012. These are 30th June 2011 and 30th November 2011. Applications can be submitted at any time throughout the year, and will be kept until the next deadline.
