## 12. Climate change

### 12.3 Climate change as part of sustainable development



One Wales: One Planet is the Welsh Government's Sustainable Development Scheme.

It sets out the Welsh Government's vision of a sustainable Wales and the priority it attaches to sustainable development. Achieving the vision of the Scheme requires all organisations in Wales to actively commit to sustainable development as their central organising principle.

### **Sustainable Resource Use**

One Wales: One Planet sets out a vision for sustainable resource use:

'Within the lifetime of a generation we want to see Wales using only its fair share of the earth's resources.'

This includes a target to reduce greenhouse gas emissions by 3% a year in those areas where the Welsh Government has devolved competence. Sustainable development therefore links to the need to reduce our carbon footprint in the third sector.

### **Wellbeing and social justice**

Key to the vision for sustainable development is the wellbeing of Wales whilst living in the environmental limits. This incorporates healthy, prosperous, safe and strong communities with everyone have access to decent housing and community facilities. It is also vital to have a fair and just society where all citizens are empowered to determine their own lives and shape their communities.

This link between wellbeing, equality and social justice whilst living in a way which reduces the environmental impact is key to understanding how the third sector can contribute to sustainable development and the climate change agenda. Many third sector organisations are already working to improve its communities and beneficiaries wellbeing therefore to act 'sustainably' in its fullest sense, third sector organisations will need to meet their core objectives within our fair share of the earth resources, which in simple terms, means reducing your organizational carbon footprint.

## **The Sustainable Development Charter**

The Welsh Government aims to encourage and enable other organisations to make sustainable development their central organising principle. The way we intend to achieve this is through the Sustainable Development Charter.

The Charter:

- Sets out our vision of a sustainable Wales;
- Links the central organising principle to the pursuit of the long-term well-being of people and communities in Wales;
- Describes the benefits making Sustainable Development your organisation's central organising principle;
- Sets out the commitment that you are making by signing up; and
- Explains the next steps we will take to support Charter.
- Signing up to the charter

The Welsh Government provides support and advice for organisations. Charter members are invited to an annual event to share learning and experiences with others, and to showcase best practice examples of their work. A number of third sector organisations have signed up to the Charter, including WCVA.
