7.4.1 Small grants



Overview

This information sheet is designed to give details about small grants, *i.e.* up to the amount of about £15,000, which are available for small groups and organisations within the voluntary sector in Wales. The entries in this sheet are intended as a general guide, the contacts given will be able to provide you with more detailed information.

Allen Lane Foundation

The Foundation provides grants for voluntary not-for-profit organisations in the UK. Overall, the Foundation wishes to fund work which will make a lasting difference to people's lives rather than simply alleviating the symptoms or current problems, as well as projects that are aimed at reducing isolation, stigma and discrimination and that encourage or enable unpopular groups to share in the life of the whole community. Grants may be used for start-up, core or project costs and generally range from £500 to £15,000. The Foundation makes grants to organisations whose work the Trustees believe to be unpopular such as: refugees and asylum-seekers; black and ethnic minority communities; lesbian, gay and bi-sexual groups; those experiencing mental health problems, violence or abuse; offenders and ex-offenders, travellers and older people.

Coalfields Regeneration Trust

The Coalfields Regeneration Trust (CRT) is the UK's leading regeneration agency dedicated to the social and economic regeneration of Britain's coalfield communities. The Trust awards grants across the British coalfields. So far, since the Trust was launched in 1999, it has awarded grants totalling around £8.5 million to 500 groups in Wales.

In Wales the Trust is currently funded by the Welsh Assembly Government and offers a small and main grants

programme. The small grants programme known as 'Bridging the Gap', is a fast track programme targeted at small voluntary and community groups. Applications can be made for between £500 to £10,000 for small grants and up to £100,000 for Main Grants. The Trust's newly formed Welsh Grants Committee will consider capital and revenue bids.

The Trust will support projects that fit into one or more of the funding themes, which are supporting communities, learning communities, enterprising communities and supporting people into work. For full eligibility and programme details contact the Wales Office.

The Dulverton Trust

The main work of the Trust focuses on the areas of youth and education, general welfare conservation, religion, preservation, peace and security and Africa, as well as other miscellaneous causes at national level. However, there are a number of minor grants of up to £2,500 available for local and community projects across the UK. Major grants, for national or regional purposes, range in magnitude from £5,000 to £25,000. Applications are accepted only from UK-registered charities, and are expected to show what other sources of funding have been sought and secured.

The Trust does not fund the broad fields of health and medicine (including drug and alcohol addiction), projects concerning museums and exhibition centres, individual churches, the whole field of the arts, sports, individual schools, expeditions, or research projects. The Trust does not usually provide funding for salaries or endowment appeals. Applicants are encouraged to contact the Trust staff to establish eligibility before submitting an application.

Environment Wales

Funded by the Welsh Assembly Government, Environment Wales is a partnership of environmental organisations in the voluntary sector. Its aim is to contribute to sustainable development by supporting and encouraging voluntary action to protect and improve the environment in Wales. There are five grant funds, each of which can cover up to 75% of a project's costs with the balance being met from non-central Government sources.

Management grants: This fund supports new posts which are not part of the organisation's core activities. Grants range from £1,000 to £11,000. Applications need to be received by early November for awards starting on 1 April the following year. Funding can be for up to a maximum of 6 years.

Project grants: These grants are for providing materials only on *registered* sustainable development projects, where volunteers are involved. Grants average at £5,000. Capital items are limited to £800. Applications can be made at any time of the year, but funds are usually allocated by October.

Pre-project grants: These cover feasibility studies, business plans and community appraisals where studies are carried out by third parties. Grants range from £500 to £5,000.

Start-up grants: These cover the costs involved with establishing new voluntary or community groups, including hiring venues, facilities and equipment, the purchase of small items of equipment, publicity and printing costs, training, insurance etc. Up to £1,000 may be applied for.

Training support grants: Grants are available for the costs of courses and conferences (which are organised by third parties) for staff and volunteers in *registered* organisations. Travel expenses, subsistence and course fees are covered.

The Foundation gives grants, up to a notional limit of £15,000 only for proposals of a charitable kind, usually from organisations, which should normally be registered charities or otherwise tax-exempt. Organisations must be located within the UK or the Republic of Ireland and good quality applications from places outside London are especially welcome.

The Trust funds categories such as work with: elderly people; children and young people; people with disabilities or mental health problems; people trying to overcome problems such as addiction, abuse, relationship problems, a history of offending; and lifelong learning. Applicants must have charitable status, have been constituted and operating for at least three years, and a normal turnover of less than £60,000 per year. No grants are given for capital expenditure.

Priority for ongoing grants is given to applicants from very small charities.

Communities First Trust Fund

Communities First is a Welsh Assembly Government regeneration programme targeting the most deprived communities in Wales. The Trust Fund, provides small grants for groups in Communities First areas for any type of activity that involves local people through community-led organisations. The fund, administered by WCVA, is aimed at supporting activities that provide economic, environmental, social or cultural benefit for people.

Communities Investment Fund

As part of CFSN the Communities Investment Fund was launched by WCVA in collaboration with its project partners, Development Trusts Association Wales and Wales Co-operative Centre, to make long term investments through a flexible loan funding package.

This is supported by development grant assistance which is aimed at helping organisations towards loan readiness.

The Fund will help build the sustainability of independent community-based voluntary social enterprises and organisations located in Communities First areas within Objective One areas which are unable to raise sufficient funding from more conventional sources. This is a key strand in the Welsh Assembly Government's programme to address social exclusion, and will be achieved by helping to develop business capacity to generate income, by raising the level of business skills in managing assets successfully, and by encouraging the running of good quality business operations.

Millennium Volunteers

Millennium Volunteers is an UK wide programme for young people who are interested or involved in volunteering. The purpose of the programme is to promote and recognise a sustained commitment by young people aged 16-24 to voluntary activity which makes a clear impact on the community.

In Wales the programme is managed by the MV Advisory Panel, a partnership between WCVA and the Council for Wales of Voluntary Youth Services. Applications can be made for sums £50 to £7,000 to cover volunteers' costs. There is no restriction on the number of applications that can be made.

Applications from youth-led projects can be approved very quickly through a fast track system. The advisory panel meets four times per year.

Volunteering in Wales Fund

The Volunteering in Wales Fund supports projects whose aims are mainly achieved by volunteers; that recruit and place volunteers; that develop good practice in volunteering; or that encourage activities in areas where volunteering is less well developed. Any constituted voluntary organisation working, or planning to work in Wales, is eligible to apply. Grants of up to £25,000 are available in the first year, and there is an opportunity to apply for second and third year funding of up to £12,500 and £6,250 respectively.

Local Mental Health Grants Scheme

This small grant scheme is a one off grant and the maximum grant limit (per project) is **£3,000** available to eligible organisations.

Applications are invited under this scheme from constituted voluntary organisations. The purpose of the scheme is to support and enhance the voluntary sector contribution to the care of adults experiencing mental health

problems, and their families and carers, in Wales.

A wide range of projects can be considered for funding including:

- provision of equipment and improved accommodation;
- publications;
- research;
- training for staff and volunteers;
- one off activities.

The beneficiaries of this scheme must be those suffering mental health problems, their families or carers in Wales.

This scheme does not support children's services.

The scheme is aimed primarily at groups and organisations that are either not currently receiving funding, or are receiving less than £10,000, from the existing Local Mental Health Main Grants or SPD scheme.

This scheme has now closed to 2009 applications.

Welsh Language Board

The aim of all the Welsh Language Board's Main Grants Scheme is to increase the use of Welsh. The Board can distribute grants to support activities that aim to fulfil this objective. Grants are available to support activities of organisations if promoting and increasing the use of the Welsh language is an integral and central part of its constitution.

Organisations may apply for a grant towards holding appropriate activities, supporting core costs and salaries, as well as other costs relating to running the organisation.

If promoting and increasing the use of the Welsh language is not an integral part of the constitution, organisations may still be eligible to apply if the programme's objective is to increase the use of the Welsh language in Wales. This could include programmes that (although this list is not intended to be exhaustive):

- create new opportunities to use the language;
- provide information to people regarding the opportunities available to them to use the language;
- encourage and support the use of Welsh;
- safeguard and develop the activities of organisations and movements established to promote the Welsh language;
- produce resources to facilitate the use of Welsh.

There are also grants for producing bilingual materials (e.g. leaflets and signs) available through the Business Grant Busnes Scheme.
