7.4.13 Local funding - Merthyr Tydfil



This information sheet is designed to give details about small grants, which are available for small groups and organisations within the voluntary sector in Merthyr Tydfil. The entries in this sheet are intended as a general guide, the contacts given will be able to provide you with more detailed information.

This sheet should be read in conjunction with **7.4.1 Small Grants** which details small grants which are available on a regional or all Wales basis.

Voluntary Action Merthyr Tydfil Capacity Building Small Grant Scheme.

The Voluntary Action Merthyr Small Grants Scheme is funded by Merthyr Tydfil County Borough Council and the Welsh Assembly Government's Community Facilities and Activities Programme, which helps community and voluntary organisations provide facilities or carry out activities which will promote the regeneration of communities.

The grants scheme is open to local organisations whose beneficiaries are within the County Borough of Merthyr Tydfil. This includes:

- organisations only working in one ward or one area of the borough
- borough-wide organisations or

- local branches of national organisations.

National organisations themselves are ineligible to apply.

The scheme will support applications for capital (e.g., equipment, building work), and revenue (e.g. running costs, rental etc) costs.

The maximum grant that can be applied for is £5,000.

Merthyr Tydfil Community Trust Small Grants Scheme

This fund is available to small voluntary and community groups for any charitable purpose (excluding religious activities).

Grants awarded will not normally exceed £200. The application must be for an activity based in the County Borough of Merthyr Tydfil.

Applications can only be considered from organisations whose income in the last financial year was less than £10,000.

Merthyr Tydfil Development Fund

The Merthyr Tydfil Development Fund is an annual fund which voluntary and community organisations working in the County Borough of Merthyr Tydfil can apply to for grants to support projects benefiting people in Merthyr Tydfil.

It is managed by Merthyr Tydfil County Borough Council working in partnership with Voluntary Action Merthyr Tydfil.

Voluntary and community organisations working in the County Borough of Merthyr Tydfil, which are able to demonstrate that their goals will benefit the community can apply for a grant providing they:

- Are a not for profit group.
- Have a constitution or set of rules that have been signed or “adopted”.
- Have a Bank or Building Society account with at least two joint signatories.
- Have your most recent Annual Accounts or Statement of Income and Expenditure (audited or signed as approved by a senior person from your group).

Grants range from £5,000 to a £25,000 and grants are for a maximum of 1 year.

Welsh Church Act Fund

The Welsh Church Act Fund grant scheme is available to voluntary and community groups operating in Rhondda Cynon Taff, Merthyr and Bridgend. It provides funds to organisations that have charitable or alms giving purposes, for capital expenditure only.

Who Can Apply?

- Applications invited from Churches, Chapels, Community Organisations and Charities.
- Applications will only be considered from organisations working in Rhondda Cynon Taff, Merthyr and Bridgend.
- In considering applications from organisations, which exist to provide hobby activities for its members, the facilities, which they provide, should be available to members of the public at large, and any assistance given will be towards projects/expenditure of a capital nature incurred by the organisation.

What Can It Fund?

Applicants can apply for grant support for the following purposes:

- Support for places of Worship and Community Buildings
- Small items of equipment
- Works to comply with the Disability Discrimination Act
- Other purposes beneficial to the community.
- Normal running expenses will not be supported.
- No grants will be made to clubs with a liquor licence.
- Retrospective costs i.e costs for work already undertaken or equipment that has been purchased prior to a formal grant offer, are ineligible from this fund and should not be included in any application you may wish to make.

Applicants can apply for **capital costs** (including repairs and renewals) and may be awarded the following grant rates:

Category	Maximum Grant	Match Funding Contribution
Small	Up to £1,500	Nil
Large	Up to £10,000	At least 50%

Examples

- If you were undertaking a project at a value of £30,000 you could apply for a maximum grant of £10,000.
- If you were undertaking a project at a value of £2,000 you could apply for a maximum grant of £1,500.

Please note that should your project be successful that payment will only be made on submission of invoices **at the completion of the project.**

There are no set deadlines for applications, however there are limited financial resources available.

Sports Council for Wales - Community Chest Grant

Community Chest is a Sports Council for Wales, National Lottery grant funded scheme that is designed to encourage more people to become more physically active more often. Under new guidelines, the maximum grant awarded has been increased to £1,000, however if you are a club then you are now eligible to apply for £1,000 for club development and also for a further £1,000 for physical activity/health initiatives within your club.

The grants can be used to support amongst other things:

- Walking or cycling projects
- Projects to encourage employees to become more physically active
- Recruitment and development of volunteers, leaders and coaches
- Extending existing sports clubs to provide new activities
- Parent recreational session whilst their children are training in a club session

**Merthyr Tydfil County Borough
Council - Early Years &
Development & Childcare
Partnership (EYDCP) Grants**

Several grants are available from the
Early Years Development and Child
Care Partnership (EYDCP)

- Sustainability Grant for Sessional
Childcare Providers
- Small Equipment Grant for Parent
and Toddler Groups
- New Places Grant for New Sessional
Childcare Settings.

The EYDCP also give start-up grants to
new child minders and small equipment
grants to existing child minders.

With the exception of the New Places
grant and the childminder start-up grant,
applications are sent to all providers that
are registered with the Children's
Information Service and it is a condition
of the grants that providers be
registered on this data base.

Grant application forms for new
childminders are handled by the NCMA
Development Officer.

**Merthyr Tydfil County Borough
Council – Social Enterprise
Capital Assets Grant**

The Merthyr Tydfil County Borough
Council's Social Economy Team is
encouraging all existing and potential
social enterprises, as well as voluntary
and community groups to apply for a
grant through their 'Growing Social
Enterprise Project'. The scheme, which
is funded by European Objective 1
funding through WEFO, can help
organisations take that next step to
becoming more sustainable in the long
term.

Organisations, looking to develop their
trading activity, can apply for up to
£10,000 for equipment and capital
expenditure. This may include essential
equipment for a project, refurbishment
of an office or building, or even install a
new IT or phone network. The final
closing date for applications is 31
December 2007, although applications
will be assessed as soon as they are
received by the team.

The Social Economy team also offers
advice, mentoring and business support
services for all groups looking to
develop their trading activities.
